

NOTICE ON THE PROCESSING OF PERSONAL DATA

Pursuant to Article 13 of EU Regulation 679/2016

Dear Customer.

We would like to inform you that the personal data you provide, or that we acquire during the course of our activities, which are necessary for the execution of the contract in place between the parties, will be processed in compliance with applicable regulations and in accordance with the principles established by law.

Your data will therefore be processed in accordance with the principles of fairness, lawfulness, transparency and protection of your privacy and rights.

In particular, we would like to inform you of the following:

a) <u>Identity and contact details of the Data Controller</u>

b) Purpose and legal basis of processing

Your data will be processed to execute the contract currently in place between you and our Company, as well as to comply with legal obligations.

c) Parties to whom data may be disclosed

Your data may be disclosed, to fulfill the agreed-upon service, to entities by way of example but not limited to, accounting or tax consultants, banking or credit institutions, insurance or transport companies. Only data that are strictly necessary for performing the requested service will be disclosed, and, where possible, anonymized processing methods will be preferred.

The communication of such data is mandatory to execute the stipulated contract. Any refusal to communicate them will prevent us from delivering the agreed services.

Your data will in no way be disclosed to third parties without your prior and specific consent.

d) <u>Data transfer to a third non-EU country or international organizations</u>

Your data will not be transferred to non-EU countries or international organizations.

A copy of your data is available at the Data Controller's office, which can be contacted using the details provided in section (a) of this notice.

e) Retention period of personal data

Your data will be retained only for as long as is strictly necessary to fulfill the agreed contractual services, in compliance with other civil and tax regulations that may require additional retention periods.

f) Rights of the data subject

At any time, you have the right to request access to your data, as well as their rectification or deletion. You will receive a response within 30 days, either in writing (including electronically) or, upon specific request, orally. You also have the right to request restrictions on data processing or object to it altogether. You have the right to request the portability of your data to another controller. Additionally, you may at any time revoke any consents provided under this notice. To revoke one or more consents, simply contact the Data Controller using the details provided in section (a) of this notice.

g) Right to file a complaint with the Supervisory Authority

If you believe your data has been processed unlawfully, you have the right to file a complaint with the Supervisory Authority.

h) Mandatory or optional nature of data provision and consequences of failure to provide data

Providing your data to the Data Controller is mandatory only for data necessary to fulfill the purposes outlined in section (b). Failure to provide the required data will prevent the proper execution of the stipulated contract, making it impossible to fulfill.

i) Automated decision-making processes

The Data Controller does not use any form of automated decision-making processes concerning your personal data.
